INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Goetzel 32C-30-M flowline abandonment. Approximately 247' of flowline was abandoned-in-place due to common trenching with at least one other line, as per Form 44 Document Number 404380969. Soil samples were collected beneath the flowline risers at the wellhead and separator. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the Goetzel 32C-30-M wellhead cut and cap. The wellhead will be cut and capped per ECMC rules. The wellhead cut and cap analytical results will be submitted on a subsequent Supplemental Form 27.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were collected beneath the flowline risers at the wellhead and separator. Soil samples were and will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during the site investigation a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the flowline areas occurred during flowline decommissioning activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. A detailed summary of flowline decommissioning activities, including field notes, site photos, figures, and laboratory analytical results was attached to ECMC Document Number 404316867.

On June 6, 2025, three background soil samples were collected from one discrete location (BKG01) adjacent to the flowline and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths of approximately 2 ft, 3 ft, and 4 ft bgs. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 6.4 mg/kg and 128 mg/kg, respectively. Based on the results, barium remains in exceedance of ECMC standards and background concentrations in soil sample location FL01R-W@7'.

Based on the analytical results collected during flowline abandonment activities, a supplemental site investigation (SSI) will be completed to collect additional background samples to determine if the barium exceedance observed at FL01R-W@7' is attributed to native soil conditions on site. Flowline abandonment analytical results indicated that organic compound concentrations were in compliance with ECMC regulatory standards in both soil sample locations. Background analytical results indicated that barium was in exceedance of ECMC standards and background concentrations in FL01R-W@7'.

Based on the analytical results collected during flowline abandonment activities, a supplemental site investigation (SSI) will be completed to collect additional background samples to determine if the barium exceedance observed at FL01R-W@7' is attributed to native soil conditions on site. The proposed soil boring locations were included and approved on ECMC Document Number 404316867.
