INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the TIMBRO FEDERAL LD18-74HN wellhead cut and cap and flowline and gas line removal. The wellhead was cut and capped per ECMC rules September 12, 2024, and a historic release was reported in Form 19 document number 403943228. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Supplemental source mass removal activities by the wellhead occurred on June 3 and 4, 2025. Results were summarized via supplemental Form 27 document number 404342166.

The flowline and gas line were removed on November 5, 2024. Soil samples were taken along the flowline and gas line at any points of material change and/or hammer unions, directional changes. The November 5, 2024, flowline decommissioning sample results were summarized via supplemental Form 27 document number 404241729.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

- Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Eight soil samples were taken along the flowline and gas line at any points of material change and/or hammer unions, directional changes. Six confirmation soil samples were collected from the final extents of the excavation at the wellhead on June 3, 2025. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater sample will be collected and analyzed for all organic compounds and inorganic parameters per ECMC Table 915-1.

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. A detailed summary of flowline decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was attached to Form 27 Document Number 404241729. A detailed summary of source mass removal activities, including field notes, site photos, figures, and laboratory analytical results, was attached to Form 27 document number 404342166.

Ten background soil samples were collected along the flowline on 11/4/2024 from an area not impacted by oil and gas development and at depths and lithologies (silty sands – SM) comparable to those of the confirmation soil samples collected at the location. The samples were analyzed by a certified laboratory for Table 915-1 metals and SSR parameters using ECMC approved Methods. Four background soil samples were collected near the wellhead on 6/4/2025 and after further review, were determined to be within the historic oil and gas impacted area and will not be used to determine site specific background concentrations of Table 915-1 metals in soil and SSR parameters per ECMC Table 915-1. Additional background samples will be collected to determine site specific background concentrations of pH, arsenic, barium, and lead.

Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. SOURCE REMOVAL SUMMARY

On June 3, 2025, 50 cubic yards of impacted material at the wellhead was removed and hauled to a permitted disposal facility, Buffalo Ridge Landfill. Confirmation samples collected after excavation were analyzed for the full Table 915-1 suite, and results indicated all organic impacts have been removed. Refer to the Remediation Summary and Operator Comment sections for additional work planned to address remaining inorganic impacts.

Wellhead decommissioning activities and confirmation soil sampling at the Timbro Federal LD18-74HN wellhead occurred on September 12, 2024 and a historic release was reported in Form 19 document number 403943228. Hydrocarbon impacted material at the wellhead was removed and hauled to a permitted disposal facility.

A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH, arsenic, barium, and lead are attributed to native soil conditions at the site. The proposed background sample locations are included in the Site Map attached to Form 27 document number 404342166. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. The results of the SSI will be submitted on a subsequent Form 27.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the Timbro Federal LD18-74HN wellhead and flowline and necessity for supplemental site investigation activities adjacent to the wellhead and flowline.

OPERATOR COMMENT

This Form 27 is being submitted to include a 1Q 2026 update for the Timbro Federal LD18-74HN wellhead (REM #35388). A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH, arsenic, barium, and lead are attributed to native soil conditions at the site. The results of the SSI will be submitted on a subsequent Form 27.

The November 5, 2024, flowline decommissioning sample results were summarized via supplemental Form 27 document number 404241729. The Site Map attached to the Form 27 Initial (ECMC Document Number 403773445) included one soil sample on the flowline separator riser at the site. The separator flowline riser sample was not collected during the flowline decommissioning completed on November 5, 2024. However, the flowline riser was sampled during the Timbro Federal LD18 74HN tank battery (REM# 35422) Decommissioning and are represented by sample locations FL01R-S and SEP01-FL.

Ten background soil samples were collected along the flowline on 11/4/2024 from an area not impacted by oil and gas development and at depths and lithologies (silty sands – SM) comparable to those of the confirmation soil samples collected at the location. The samples were analyzed by a certified laboratory for Table 915-1 metals and SSR parameters using ECMC approved Methods. Four background soil samples were collected near the wellhead on 6/4/2025 and after further review, were determined to be within the historic oil and gas impacted area and will not be used to determine site specific background concentrations of Table 915-1 metals in soil and SSR parameters per ECMC Table 915-1. Additional background samples will be collected to determine site specific background concentrations of pH, arsenic, barium, and lead.

On June 3, 2025, source mass removal was conducted and 50 cubic yards of impacted material at the wellhead was removed and hauled to a permitted disposal facility, Buffalo Ridge Landfill. Confirmation samples collected after excavation were analyzed for the full Table 915-1 suite, and results indicated all organic impacts have been removed. A detailed summary of source mass removal activities, including field notes, site photos, figures, and laboratory analytical results, was attached to Form 27 document number 404342166.

This project is waiting for required background samples to be collected and analyzed. We anticipate that background samples at the remediation location will occur on March 30, 2026. Landowner access has been requested and is awaiting review.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
