INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The Champlin-Hanavan #3-21 wellhead and associated off-location flowline were assessed per ECMC Rule 911.a. On 5/13/2025 2 soil samples were collected from the former wellhead, separators, and tank location; 4 background samples were collected from 2 locations at 4' and 6' bgs. All samples exceed Arsenic Table 915-1 levels; background samples indicate the Local Clean-Up Levels are 5.91 mg/kg (1.25 * 4.73 mg/kg).

Based on analytical results, further site assessment is not needed. Mull respectfully requests a No Further Action.
