INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the SCOTT WESTERMAN T7N-R64W-S32 L01 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On June 9, 2025, grab confirmation soil samples were collected from the produced water vessels excavation (PWV01-B@8', PWV01-N@7', PWV01-E@7', PWV01-W@7', PWV02-B@8', PWV02-E@7', PWV02-W@7', and PWV02-S@7'), beneath the ground oil tanks (AST01@0-6" and AST02@0-6"), at the risers for the flowlines (SEP01-FL@3' and SEP02-FL@3') and dumplines (SEP01-DL@3' and SEP02-DL@3') of any separators. In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of tank battery decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Basis for change in implementation schedule:

The implementation schedule has been changed due to the decommissioning of the SCOTT WESTERMAN T7N-R64W-S32 L01 tank battery and necessity for remedial excavation activities adjacent to the tank battery. The proposed remedial excavation will be completed following the approval of this form.

OPERATOR COMMENT

This Form 27 is being submitted to provide a summary of decommissioning activities, analytical results, and historical reportable release discovered at the former SCOTT 67N64W 32SENE Tank Battery location.

Tank battery decommissioning activities occurred at the above referenced location on June 9th, 2025. Discrete soil samples were collected from beneath the former facility infrastructure as described in the approved Form 27-Initial (Document number 403579602). Analytical results indicated that soil samples PWV01-B@8', PWV01-E@7', PWV02-B@8', PWV02-S@7', and SEP01-DL@3' exhibited organic compound concentrations in exceedance of the regulatory standards.

Based on decommissioning analytical results, remedial excavations will be conducted to remove the sources identified at soil sample locations PWV01-B@8', PWV01-E@7', PWV02-B@8', PWV02-S@7', and SEP01-DL@3'. Soil samples will be collected from the base and sidewalls of the final excavation extent and submitted for laboratory analysis of the full ECMC Table 915-1 suite. Concurrently with the remedial excavation, additional background soil samples will be collected to determine if arsenic, barium, cadmium, lead, and selenium are attributed to native soil conditions at the site.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of remedial excavation will be submitted on a subsequent Form 27.
