Comply with Rule 1004. Reseed disturbed areas and bare areas using a seed mixture requested by the surface owner or a mixture prescribed by the local county NRCS. Establish vegetation with a total perennial, non-invasive, uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. The operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Comment: Due to the topography and the presence of bare soil, there is a potential threat that stormwater runoff will transport sediment off-site and impact sensitive riparian habitat. Stabilization of bare soil is needed to prevent sediment transport off-site.

Comply with Rule 1002.f. to implement and maintain BMPs to control stormwater runoff in a manner that minimizes erosion, transport of sediment off-site, and site degradation. BMPs shall be maintained until final reclamation is achieved pursuant to Rule 1004.
