Twenty-two (22) grab confirmation soil samples were collected for analysis by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, four (4) grab soil samples were collected for analysis of Table 915-1 metals.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during excavation activities, a grab sample will be collected for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, TDS, chlorides, and sulfates.

Source removal is complete. Grab confirmation soil samples were collected for laboratory analysis of Table 915-1 metals, organics, EC, pH, SAR, boron, and TPH C6-36.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

A statistical analysis was completed using the Wilcoxon Rank Sum Test for concentrations of arsenic, barium, cadmium, lead, selenium, pH, SAR, and EC. Background and source confirmation concentrations were statistically similar for arsenic, barium, cadmium, lead, selenium, EC, and pH and these concentrations should be considered naturally occurring. SAR is not statistically similar. A site assessment was completed to delineate SAR. SAR remains in situ above ECMC standards. Per ECMC Table 915-1 footnote 3, the concentrations of SAR left in situ above ECMC standards are proposed to be modified due to land use, depth, and vegetative community, may be used to propose a no further action. Past Summit Scientific analytical data is currently being reviewed. The estimated timeframe to achieve a no further action will be October 31, 2026.

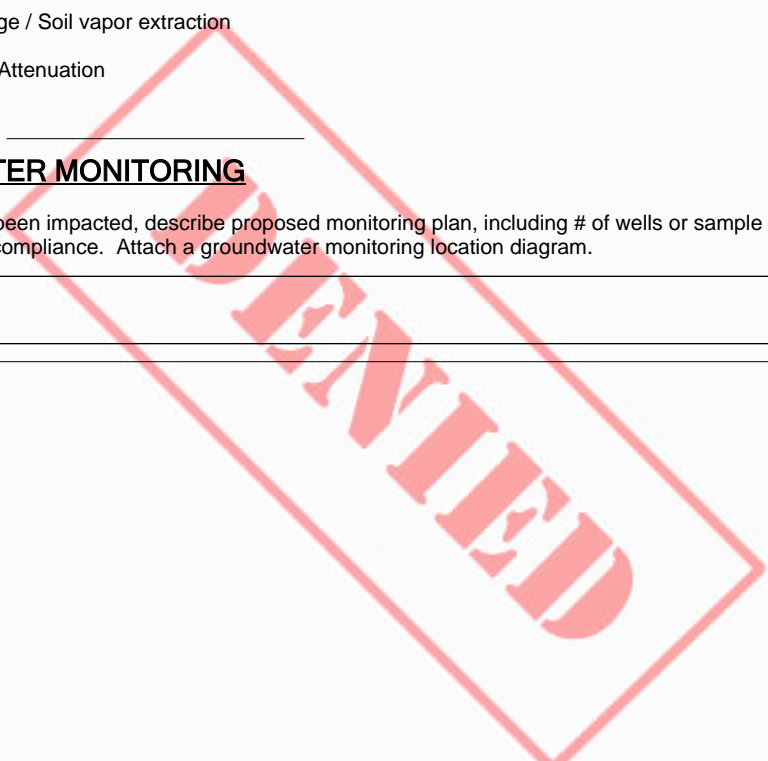
