INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Segal 8-2-24 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Laboratory analytical results did not indicate a historical release occurred at the decommissioned wellhead. Please refer to the operator comments for additional information regarding the historical release and remedial efforts to be conducted at the wellhead.

Approximately 824' of flowline will be abandoned-in-place. This flowline lies in a common trench with at least one other line. So as to not disturb the other line(s) sharing the common trench, soil samples will only be taken at the wellhead and at the endpoint of the flowline. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected from the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area occurred during decommissioning activities. The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the wellhead.

OPERATOR COMMENT

Facility closure activities and confirmation soil sampling were conducted at the Segal 8-2-24 wellhead on May 15, 2025, where the potential presence of impacted material(s) was identified via hydrocarbon odor and was reported under initial Form 19 document number 404207593. However, the final analytical results of initial soil sampling confirmed the samples did not exceed ECMC standards for BTEXN, TMBs, TPH, and PAHs, detailed below. Therefore, the suspected release did not occur and was below Rule 912.a.(5) reporting thresholds.

Discrete soil samples were collected from beneath the wellhead, WH01@6, and from the sidewall with this highest screening, WH01-E@4. Analytical results indicated that the soil samples exceeded ECMC Table 915-1 standards for arsenic in WH01@6 (4.36 mg/kg) and WH01-E@4 (4.22 mg/kg), barium in WH01@6 (106 mg/kg) and WH01-E@4 (131 mg/kg), and lead in WH01@6 (14.9 mg/kg). Groundwater was not encountered during excavation of the wellhead for decommissioning activities.

PDC proposes to conduct background soil sampling from boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted.

Flowline decommissioning activities will be conducted by another consultant and will be summarized in a Supplemental Form 27 submittal as available.

The data were reviewed for compliance with the analytical method and the associated quality assurance/quality control (QA/QC) procedures. Chain of custody forms were properly executed, and data were reported using the correct methods and reporting units. The results of the QA/QC assessment indicate that data precision and accuracy are acceptable.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
