Operator Comment: Citation consulted the landowner about reclaiming the former facility location in compliance with 1004 series rules. The landowner provided Citation a written response "Exhibit C" (see last page of attachment A). The landowner states he wants the location left "as-is" stating that he uses the cattleguard and roads to access his pasture and water tank for ranching operations. The landowner is also concerned that the area has already been

healed and to disturb, rip or contour the area would not only destroy existing pasture grass but cause sand to begin to blow at the location, resulting in further damages. The operator procured a signed variance letter from the landowner waiving reclamation requirements under ECMC Rules 502.b and 1001.c. (see attachment A). The operator will be seeking a variance hearing in compliance with rule 309.b(2).
