The implementation schedule has been changed due to the decommissioning of the Heartland C30-79-1HN flowline. Operator was informed by the laboratory that the sample holding times were exceeded for various Table 915-1 constituents in the samples collected during the flowline decommissioning activities conducted on 03/28/2025. Replacement samples will be collected and submitted for full ECMC Table 915-1 analysis. Resampling activities are tentatively scheduled for completion by the end of the first quarter 2026.

OPERATOR COMMENT

This Form 27 is being submitted to maintain quarterly reporting compliance during the first quarter of 2026 for resampling activities at the Heartland C30-79-1HN flowline (REM #38691) location.

Flowline decommissioning activities occurred at the above referenced location on 03/28/2025. Analytical soil samples were collected at the wellhead riser and at the separator riser of the flowline during decommissioning activities. Operator was informed by the laboratory that the sample holding times were exceeded for various Table 915-1 constituents in the samples collected during the tank battery decommissioning activities conducted on 03/28/2025.

A supplemental site investigation (SSI) will be completed to recollect samples originally obtained during the flowline decommissioning activities, which were analyzed outside of their allotted hold times. Each soil sample will be collected and submitted for the full ECMC Table 915-1 suite. The resampling activities are tentatively scheduled for completion by the end of the first quarter 2026.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The analytical results from the resampling activities will be submitted on a subsequent Form 27.
