INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the Brown 44-24 wellhead cut and cap and flowline abandonment. The wellhead was cut and capped per ECMC rules. Approximately 558' of flowline was temporarily abandoned in place and will be removed. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples will be analyzed for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Wellhead and Flowline Closure Checklists were utilized and filled out during the abandonment process. Photologs were included with site investigation reports.

Six site specific background soil samples were collected from approximately 4 ft., and 6 ft-bgs from three soil boring (BKG01 through BKG03) in an area away from oil and gas infrastructure and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods. Analytical results are pending review and will be summarized in the next quarterly submittal.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted.

The flowline was temporarily abandoned in place due to field constraints. Flowline decommissioning activities will be completed by another Chevron business partner and will be summarized in a subsequent Supplemental Form 27 submittal. Noble will complete the decommissioning of the site infrastructure as outlined in the approved Initial Form 27 (Document Number 403185177).

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
