INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECOM Rule 911 a site investigation will be conducted pertaining to the BICKLING E21-02 wellhead cut and cap. The wellhead was cut and capped per ECOM rules on 1/12/2026. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Final analytical results are pending and will be reported on a supplemental Form 27.

The flowline was previously abandoned on 1/18/2019, and the ECOM was notified on Form 44 Document number 403216804. The flowline is now planned for partial removal. Approximately 3498' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECOM will be updated in a supplemental Form 27. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will also be taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The updated Flowline Pre-Abandonment Notice Document number is 403673033.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples will be field screened at the N-E-S-W sides of the wellhead. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were and will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECOM Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECOM laboratory analysis methods.

Visual inspection of the wellhead area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECOM Wellhead Closure Checklist was utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27. Final analytical results are pending and will be reported on a supplemental Form 27.

OPERATOR COMMENT

This Form 27 is being submitted to include a 1Q 2026 timeline update for the BICKLING E21-02 wellhead and flowline (REM #43025). Wellhead cut & cap activities were conducted pertaining to the BICKLING E21-02 wellhead on 1/12/2026. Final analytical results are pending and will be summarized in a subsequent supplemental Form 27 submittal. SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required.

The scope of work has been updated to include the partial flowline removal. An updated Form 44 was submitted under Form 44 Document Number 403673033. An updated site map with proposed sample locations will be included in the next supplemental Form 27 with updates for decommissioning work.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
