**This Warning Letter is to inform you that JOEMAR WYOMING OPERATING LLC (“Operator”) may be in violation of the rules and regulations of the Colorado Energy and Carbon Management Commission (“ECMC”) and corrective action is required.**

ECMC has reasonable cause to believe that Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which ECMC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 525, ECMC Rules of Practice and Procedure, 2 CCR 404-1.

#### **Alleged Violation(s) and Required Corrective Action(s):**

219 Form 10, Certificate of Clearance

Violation Date: 02/05/2026

Violation Discovery Date: 03/17/2026

Description of Alleged Violation: Operator received ECMC approval for the Transfer of Operatorship - Form 9 Subsequent for the subject Well (Document No. 404471763) on 01/07/2026. The conditions under which the Form was approved included the requirement to Submit a Form 10 - Change of Transporter/Gatherer within 30 days, Pursuant to Rule 219.d..

Per Rule 219.d., a new Operator will file a Form 10 within 30 days of the date the Director approves the Form 9 – Subsequent, pursuant to Rule 218.f.

As of March 17, 2026, Operator has not submitted a Form 10. Operator has failed to comply with ECMC Rule 219.d. and has violated the Condition of Approval..

Required Corrective Action: Operator will submit a complete and accurate Form 10 change of Transporter/Gatherer. The Form 10 will also include details describing the procedures Operator will employ in the future to ensure compliance with Rule 219.
