On 2/12/2026, BOOTH 23-1214 wellhead and flowline supplemental site investigation activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 2/26/2026, indicate the soil sample, 17638-FL-01-R-SO-4-20260212, discovered along the former flowline exceeded ECMC Table 915 standards for naphthalene at 0.0249 mg/kg. Groundwater was not encountered during site investigation activities. This location is within the Aquatic Native Species Conservation Waters High Priority Habitat.
