On 2/12/2026, BOOTH 23-1214 wellhead and flowline supplemental site investigation activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 2/26/2026, indicate the soil sample, 17638-WH-01-SO-8-20260212, discovered near the former wellhead exceeded ECMC Table 915 standards for TPH at 3433.0 mg/kg, naphthalene at 0.0668 mg/kg, and 1,2,4-trimethylbenzene at 0.0903 mg/kg. Groundwater was not encountered during site investigation activities.
