INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On 9/20/2024 a site investigation was conducted pertaining to the decommissioning of the WATSON 66N65W 28SWNW Tank Battery. Pursuant to ECMC Rule 911, soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Confirmation soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator. In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory using approved ECMC laboratory analysis methods for the full extent of ECMC Table 915-1, and EC, SAR, pH, metals, and boron.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic parameters per ECMC Table 915-1.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to Supplemental Form 27 Document #403962533.

On 9-20-2024, three background soil samples (BKG01) were collected near the tank battery at depths ranging from 0-0.5 and 5 feet below ground surface (ft bgs), and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 7.43 mg/kg and 226 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below background levels.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed during the decommissioning activities. A proposed SSI map is attached to this Form 27. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if elevated pH is attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
