After further inspection at the well location, the well location meets Rule 1004 vegetative standards and is reflective of reference area vegetation.

After further review of the access road, the access road continues further west which was utilized by other Operators, not Klazuba. Therefore, it is not the responsibility of Klazuba to reclaim.

The associated tank battery is being operated by another Operator.

Operator has submitted a variance request for the well location. Since the well location meets Rule 1004 vegetative standards, Operator should withdraw the variance request.
