**General Comment:**

This is a Final Reclamation Inspection for pit 116857. Inspection was performed at the State Land Board's request. Pit has no status, but field inspection confirmed that it was closed.

The well closest to the pit (API 087-06538) was originally drilled by Kimbark, but the operator changed. Kimbark resigned as the operator of the well effective April 1st, 1986. Pit was not included in the transfer; however, in a letter to ECMC from Weaselkin Corporation on 4/7/1989, it was indicated that they "will do some remedial work on the pits." Change of operator again on January 1st, 1992. plugged in Jun 1993. Request for inspection for bond release 11/22/1995 inspected 11/30/1995 passed final reclamation.
