INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to ECMC rule 911 at the Antelope/P-17 PAD (428964) oil and gas location pertaining to the cut/cap of the ANTELOPE P-T-17HZ (05-123-35600). The on-location flowline and separator associated with the well will be decommissioned. All other wells and equipment will remain active. See site map exhibit for details.

Eight (8) grab soil samples were collected from the decommissioned facilities, and two (2) composite soil samples were collected from the stockpiled overburden. All soil samples were submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron.

Excavation activities will be initiated at the wellhead and separator to remove the concentrations of organic constituents above their applicable ECMC Table 915-1 standards. Verification sampling will be initiated following excavation activities to verify the levels of barium, hexavalent chromium, lead, selenium, pH, and EC if those samples aren't included in the excavations.

The source will be removed through mechanical excavation. Grab confirmation soil samples will be collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron to determine the lateral and vertical extent of impacts. Background samples will be collected from homogenous soil horizons and/or corresponding excavation sample depths.
