Comment

Interim areas are used by cattle. Interim areas are composed of perennial grasses such as intermediate wheatgrass and Russian wildrye. Portions of the fill slopes are dominated by kochia, an undesirable plant species. Ongoing weed monitoring and maintenance is necessary until the location receives a passing final inspection. Some portions of the fill slopes are patchy or bare; however, perennial bunchgrasses are present and vegetation may need more time to develop in these areas. Overall, interim areas at the location are progressing towards 1003 reclamation requirements.
