OPERATOR COMMENT

This Supplemental Form 27 is being submitted as a Q3 2025 update for RPN 9341. An Operations and Maintenance (O&M) update and system performance table have been provided as attachments to this form. Soil Vapor Extraction performance remains consistent along with photoionization readings. The spike in volatile organic compounds removal suggests the SVE system is removing hydrocarbon contamination at a greater rate than was anticipated. HRL will continue with quarterly O&M visits and vapor sampling in Q4 2025 and will address system adjustments as necessary.
