INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WILMOTH 14-0314 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 505' of flowline was removed; however, a portion was abandoned in place.

Grab soil samples were collected from the wellhead excavation, flowline terminus at the separator, directional change, and cut-point of abandonment. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1.

Two background sample were collected from similar lithographic soil near the wellhead and flowline. Background soil samples were analyzed by a certified laboratory for ECMC Table 915-1 metals, boron, EC, SAR, and pH.

OPERATOR COMMENT

This is a quarterly update and resubmittal of duplicate Forms # 403972039 and # 403971573.

The previous approved Form 27, #403737353, contained the following COAs:

1) Operator has failed to adhere to the quarterly reporting schedule. Verbiage in this form implies that the flowline had been decommissioned at the time of this form submittal, 4/1/24, at the time of this review, 9/25/24, no flowline data has been submitted, 177 days. Operator shall submit all available data as soon as practicable.

2) All soils do not meet Table 915-1 standards. Multiple soil samples exceeded Table 915-1 standards for pH and one exceeded for SAR. These values are not representative of native soils based on comparison to the background data provided.

The Operator acknowledges these COAs are outstanding. The Operator intends to provide the flowline data with the next quarterly submittal, and submit future quarterly updates within their 90-day windows.

The Operator intends to collect additional background samples from soil of native/similar lithographic material to further compare residual pH and or SAR associated with the flowline.
