INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the Sater CC 18-17D (AKA Sater CC18-18) facility and tank battery location on 04/08/24 and 04/09/24. Grab confirmation soil samples were collected from the base of the produced water vessel (PWV) excavation (FS01@4') and the sidewall exhibiting the highest screening level from the E wall (SS02@3'), beneath the ground oil tanks (AST01@0.5' & AST02@0.5'), and beneath the risers for the flowlines (SEP01-FL@3' & SEP02-FL@3') and dumplines (SEP01-DL@3' & SEP02-DL@3') at both separators. Field screening samples were collected from the N, E, W, & S sidewalls of the PWV excavation (SS01 - SS04), beneath both of the meter houses (MH01@0.5' & MH02@0.5'), and the flare (FLARE01@0.5').

Soil samples were collected as described in the Initial Action Plan section of this Form 27, in accordance with the sampling plan in the Initial Form 27. Decommissioning samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Were background samples collected as part of this site investigation?

On 04/09/24, three background soil samples were collected from one discrete location (BG01) during decommissioning of the Sater CC 18-17D Facility and analyzed for metals in soil per ECMC Table 915-1 and pH. During site investigation activities on 05/01/25, 10 additional background soil samples were collected from 5 discrete locations (BKG02-BKG06) and analyzed for metals in soil per Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging from 0.5 to 7 feet below ground surface. The maximum background pH was observed to be 8.71. The maximum background concentrations with a 1.25x multiplier applied for arsenic, barium, cadmium, and selenium were calculated to be 3.9 mg/kg, 218 mg/kg, 0.35 mg/kg, and 5.4 mg/kg, respectively. All arsenic and selenium concentrations observed during decommissioning and site investigation activities were below 1.25x the maximum background level.

Based on the pH, barium, and cadmium exceedances observed during decommissioning and site investigation activities, a background investigation will be completed to collect additional background samples (BKG07-BKG11) to determine if elevated pH, barium, and cadmium levels are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

No impacted material caused by oil and gas operations was identified at this time.

A site assessment was conducted on 05/01/25 to delineate impacted media. The results of the May 2025 SSI were previously reported under ECMC Document # 404269421.

During the May 2025 SSI, 5 soil borings were advanced to 7 feet below ground surface. BH01 was advanced at the same location as soil sample FS01@4' to vertically delineate impacts at that location. BH02-BH05 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at FS01@4'. Soil samples were collected and analyzed for full ECMC Table 915-1 constituents. Groundwater was not encountered during this assessment. Analytical results from the May 2025 site assessment indicate that the impacts at FS01 were fully delineated. Barium and cadmium exceedances were observed at sample location BH04@6-7'.

A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated pH, barium, and cadmium levels are attributed to native soil conditions at the site. This will be completed in accordance with the proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
