INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SPIKE STATE GWS CC30-02 wellhead cut and cap and flowline removal.

On 4/5/23 the wellhead was cut and capped per ECMC rules. One grab soil sample was collected at the floor of the wellhead excavation by previous consultant. Sample was analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. An exceedance of 915-1 for pH was identified in the sample collected.

On 6/5/23 two grab soil samples were collected at the flowline terminus at the wellhead (1) and the flowline terminus at the separator (1) by previous consultant. Samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. Approximately 838' of flowline was removed on 6/6/23 and ECMC was notified on Form 44 Document # 403537200. Additionally, during flowline removal soil was field screened at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. No exceedances of ECMC Table 915-1 were identified from the samples collected.

On 7/14/25 eight confirmation soil samples were collected by hand auger at the former wellhead (2) and along the flowline (6). Samples were analyzed by a certified laboratory for full ECMC Table 915-1 constituents. All samples were reported in exceedance of ECMC Table 915-1 standards for Arsenic, but found to be below site-specific background for arsenic. Four (4) samples reported in exceedance of ECMC Table 915-1 standards for selenium, but found to be below site-specific background. The site investigation data from 7/14/2025 is attached to in-process SF27 doc 404398168.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

All areas suspected of having potential impacts, including the wellhead, associated flowlines, and production equipment, were visually inspected and field screened with a PID. Using these observations and field screening results, soil samples were collected from areas most likely to be impacted. Visual inspection of the wellhead and flowline areas occurred during assessment activities. Field personnel screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. A detailed summary of decommissioning activities at the wellhead and flowline risers, including an ECMC Flowline Closure and Wellhead Closure Checklist, site photos, figures, and laboratory analytical results, were attached to Supplemental Form 27 # 403694060 and 403903228.

Background data collected by previous consultant was not utilized in the site background determination/compliance evaluation process.
A total of 10 background soil samples were obtained sufficiently away from the investigation areas to reflect native conditions not impacted by oil and gas activity, and from similar depths and lithologic materials for comparison to confirmation soil sample results. Background samples were analyzed for ECMC Table 915-1 SSR parameters and metals. Maximum background concentrations for compounds that exceed ECMC Table 915-1 in soil samples collected for closure assessment include: arsenic max X 1.25 (2.00 mg/kg, 6 ft bgs), selenium max X 1.25 (0.459 mg/kg, 3 ft bgs).

This 2Q26 SF27 for Spike State GWS CC 30-02 (REM 26817) is a quarterly timeline update. No additional site investigation activities are proposed for Q2 2026.

All samples were reported in exceedance of ECMC Table 915-1 standards for Arsenic, but found to be below site-specific background for arsenic. Four (4) samples reported in exceedance of ECMC Table 915-1 standards for selenium, but found to be below site-specific background. The site investigation data from 7/14/2025 is attached to in-process SF27 doc 404398168.

In consideration of background samples collected on 7/14/2025 all soil samples are within ECMC Table 915-1 soil standards or calculated site-specific background levels. Operator does not recommend additional site investigation activities. Upon ECMC approval of in-process SF27 doc 404398168, Operator will submit a NFA recommendation in a subsequent Form 27.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
