INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the Zabka T5N-R65W-S2 L01 facility and tank battery. The facility and tank battery were decommissioned per ECMC rules on 10/01/2025. Grab soil samples were collected at the produced water vessels excavation and the east sidewall of the excavation, the oil-water separators, and the above ground oil tanks. Additionally, soil samples were field screened at the sidewalls of the produced water tank excavation (PWV-SS01, PWV-SS03, PWV-SS04, PWV-SS05), the flare (FLARE01), and the meter houses (MH01, MH02).

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Seven grab confirmation soil samples were collected from the base and the east sidewall of the produced water vessels excavation (PWV01, PWV02, PWV-SS02) beneath the ground oil tanks (AST01, AST02), and at the dump lines of the separators (SEP01-DL, SEP02-DL). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of ECMC Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Were background samples collected as part of this site investigation?
 During the initial decommissioning on 10/01/2025, twelve background samples were collected from three soil borings (BKG01-BKG03). The backgrounds were collected between approximately 0-6 inches (in) to 5 feet below ground surface (ft bgs). All background samples collected were analyzed for ECMC Table 915-1 inorganics and metals. The maximum background concentration for pH was reported at 8.43 standard units. The maximum background concentrations for arsenic, barium, and selenium including the 1.25 multiplier were calculated to be 17.00 mg/kg, 220.0 mg/kg, and 1.662 mg/kg, respectively. The analyzed samples were within ECMC Table 915-1 standards/maximum background levels except for in soil sample location SEP02-DL@2' for selenium (2.120 mg/kg).

The impacted soil will be segregated for proper off-site disposal. The excavation is anticipated to be 10 feet (ft) x 10 ft x 7 ft. Remedial excavation confirmation soil samples will be collected from the base and sidewalls and analyzed for full ECMC Table 915-1. In response to ECMC Form 27 comment dated 04/01/2026 (Doc. #404592128), a qualified excavation crew is not immediately available but is expected to commence the work in 2Q 2026. Work will be conducted in compliance with previously approved work plans and the 900 Series Rules.

Pursuant to Rule 913.e., quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the remedial excavation and site investigation will be submitted within a subsequent Form 2
