INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations and flowline removal activities were completed at the McCoy, Phillip Unit E 1A wellhead from May 7 - August 4, 2025. Groundwater was not encountered during wellhead cut and cap or flowline removal activities. Visual inspection and field screening of soils around the well, associated pumping equipment, and flowline removal potholes was conducted following wellhead cut and cap and flowline removal operations and soil samples (WH-B01@6', WH-RIS@4', WH-S01@5', WH-W01@5', SEP-RIS@5', FL-B01@4', FL-B03@5', FL-B04@5', FL-B06@4', and FL-B07@4') were submitted for laboratory analysis of Table 915-1 Contaminants of Concern to determine if a release occurred. Laboratory analytical results indicated that the pH, 1&2 methylnaphthalene, and naphthalene concentrations in soil sample WH-S01@5', the pH, lead, and 1&2 methylnaphthalene concentrations in soil sample WH-W01@5', and the pH concentration in soil sample WH-B01@6' exceeded the applicable ECMC Table 915-1 standards and/or background limits. As such, a Form 19 Initial/Supplemental Spill/Release Report (ECMC Document 404214448) was submitted on May 23, 2025, and the ECMC issued Spill/Release Point ID 490286. Soil analytical results are presented in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figures 1 & 2. The secured laboratory analytical reports are attached. The field notes and a photographic log are attached.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On 5/7/25 - 8/4/25, soil samples were collected from the base and sidewalls of the cut & cap excavation area (WH-B01@6', WH-W01@5', WH-S01@5'), from the location where the flowline risers were disconnected (WH-RIS@4', SEP-RIS@5'), and from the directional changes of the flowline (FL-B01@4', FL-B03@5', FL-B04@5', FL-B06@4', FL-B07@4'). The samples were submitted for laboratory analysis of the full ECMC Table 915-1 analytical suite. Analytical results indicated that the pH, lead, 1&2 methyl., and/or naph. concentrations in soil samples WH-S01@5', WH-W01@5', and WH-B01@6' exceeded the applicable ECMC Table 915-1 standards and/or background limits. Additional assessment and/or excavation activities are ongoing to address the remaining soil impacts.

Proposed Groundwater Sampling

Groundwater was not encountered during initial wellhead cut and cap operations or flowline removal activities. If groundwater is encountered during remaining assessment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for all analytes listed in ECMC Table 915-1 Organic Compounds in Groundwater and Groundwater Inorganic Parameters using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On 5/7/25, visual inspection and field screening of soils was conducted at 2 sidewall locations within the cut and cap excavation area, 4 locations at the ground surface adjacent to the excavation, and 2 flowline removal potholes. Based on the inspection and screening results, hydrocarbon impacted soil was not observed at the screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance. On 5/7/25, 5 soil vapor points (SVP-01 - SVP-05) were installed adjacent to the former wellhead location following cut and cap operations. On May 19, 2025, a soil gas survey was conducted at three soil vapor point locations (SVP-03 - SVP-05). Two of the SVP locations were unable to be screened due to a GEM 5000 pump flow failure. GEM 5000 field readings were non-detect for methane at all three of the screened soil vapor points. SVP locations are illustrated on Figure 1 and SVP screening results are presented in Table 6.

Background soil samples BG01@3' - BG07@3' and BG01@6' - BG07@6' were collected from non-impacted native material adjacent to the wellhead cut and cap excavation. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters in Soils and Table 915-1 metals using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Table 3 and 5. The background sample locations are illustrated on Figure 3.
