Comment Snow cover prevented a full interim inspection. Visible interim areas appear to be dominated by smooth brome. Most interim areas appear to be progressing towards 1003 reclamation requirements of desirable, perennial and uniform vegetation of at least eighty (80) percent cover. The southwestern interim area appears to be dominated by redstem filaree, a weedy annual species. A follow-up inspection will be conducted during future growing seasons to determine compliance with 1003 Rules. Ongoing weed monitoring and management is necessary at the location.
