Comment This is a limited interim inspection due to snow cover. Some portions of the interim appear to be composed of perennial grasses and progressing towards 1003 reclamation requirements; other portions, such as the southwestern portion of the interim area, appear to be predominantly bare or dominated by mostly weedy species, such as redstem filaree. Ongoing weed monitoring and maintenance is required until the location receives a passing final reclamation inspection. A follow-up inspection will be conducted during future growing seasons to determine 1003 compliance. Additional reclamation efforts may be required in the future.
