INITIAL ACTION SUMMARY

In accordance with ECMC Rule 911, this form serves as notification for the decommissioning and abandonment of the Federal Pelican 33-08 Battery. The ground and sub-surfaces will be visually inspected for hydrocarbon impacts following equipment decommissioning. Field observations and photo documentation will be recorded in a field inspection form for submittal to the ECMC.

Grab soil samples will be collected below and/or adjacent to applicable facility equipment, as defined in the Rule 911.a.(4) guidance document (9/20/21), for field screening purposes. Discrete soil samples will be collected for laboratory analysis either in any area of observed hydrocarbon impacts, or in the sample locations designated by the ECMC guidance. Soil samples will be submitted for laboratory analysis of full Table 915-1 analytes by ECMC approved methods. See the attached Figure 1 for an illustration of the facility layout and proposed soil sample locations. At a minimum, Operator will submit one sample per above ground storage tank and per heater-treater for laboratory analysis pursuant to Rule 915. In absence of suspected impacted soils. Operator may submit field screening results and photo documentation for identified ECD, meter shed, and other process equipment. See Additional Investigative Actions below for details of PWV and pit sampling.

If groundwater is encountered during decommissioning and/or abandonment activities, a grab sample will be collected as soon as practical. Groundwater samples will be submitted for laboratory analysis of Table 915-1 Groundwater Inorganic Parameters and Organic Compounds in Groundwater.

Following decommissioning of the partially buried produced water vessel, discrete soil samples will be collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and/or exhibiting suspected impacts. The soil samples will be submitted for laboratory analysis of full Table 915-1 analytes by ECMC approved methods.

A minimum of 6 soil samples will be collected from the earthen pit. One sample will be collected from each of the four berms and samples from the floor of the pit will be collected from approximately 1 foot (ft) and 3ft below ground surface (bgs) at one discrete location and submitted for analysis of the full Table 915-1 soil constituents. See the attached Figure 2 for proposed soil sample locations.
