The source will be removed through mechanical excavation. Soil will be removed at the base of the separator inlet excavation at sample location, SEP01-INLET@3. Grab confirmation soil samples will be collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron to ensure impacts exceeding ECMC standards have been completely remediated.
