While conducting tank battery removal activities at the McDonald8-4,Magnuso1 production facility, historically impacted soil was discovered at the aboveground storage tank (AST) and produced water vessels (PWVs) 01 and 02. The historically impacted soil will be removed and disposed of and confirmation soil samples will be collected in compliance with ECMC Table 915-1.
