

WELL ABANDONMENT REPORT

This form is to be submitted as an Intent to Abandon whenever an abandonment is planned on a borehole. After the abandonment is complete, this form shall again be submitted as a Subsequent Report of the actual work completed. The approved intent shall be valid for six months after the approval date, after that period, a new intent will be required. Attachments required with the Intent to Abandon are wellbore diagrams of the current configuration and the proposed configuration with plugs set. A Subsequent Report of Abandonment shall indicate the actual work completed. Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

Technical Detail/Comments:

Operator used secondary containment for all tanks and other liquid containment.

Operator reviewed the stormwater program and implemented stormwater BMPs and erosion control measures as needed to prevent sediment and impacted stormwater runoff from entering the wetlands and surface water.

The GPS data within the form has been updated to reflect as-drilled well location.

Form 42 was submitted prior to plugging operations, Form 42 Doc #404564058. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc #404564071.

No fluids or gas migration was present prior to surface casing shoe plug being set. The plug was cemented to surface with 430 sacks of cement from 1194' - 0' with an additional 50 sks of cement at surface.

At least 100' of cement was left in the wellbore for each plug.

After cut prior to cap, Operator verified isolation by a 15 minute bubble test and no flow was observed.
