INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the RODRIGUEZ 3-35 wellhead cut and cap and flowline abandonment. Approximately 1153' of flowline was abandoned-in-place. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The wellhead was be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

On 11/19/2025, a soil sample was collected along the flowline beneath the separator riser (SEP01-FL@4') and analyzed for full ECMC Table 915-1 contaminants of concern during decommissioning of the associated DINGES 66N64W 3SWSW Tank Battery (Remediation #34055). This sample was reported under ECMC Document #404488015.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead area occurred during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. A detailed summary of flowline and wellhead decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was attached to previous Form 27 (Doc. #404520711).

On 11/4/2025, three background soil samples were collected from three discrete locations (BKG01 - BKG03) adjacent to the wellhead and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected at a depth of 4 feet below ground surface (ft bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic, barium, and selenium were calculated to be 3.1 mg/kg, 83.8 mg/kg, and 0.20 mg/kg, respectively. BKG01 & BKG02 were not utilized for native soil comparisons due to their location within pad.

A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if arsenic, barium, and selenium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required.

Analytical results from the May 2025 decommissioning activities indicated that no organic compound exceedances were detected above the applicable regulatory screening levels. All metal concentrations detected during decommissioning were below the applicable regulatory screening levels or within 1.25x the maximum background levels, with the exception of arsenic in all soil samples and barium & selenium in soil sample FL01-R@3.5'. All soil suitability parameters were within the Soil Suitability Limits or local background levels.

Based on decommissioning analytical results, an SSI will be completed to collect additional background samples to assess arsenic, barium, and selenium in native soil. The SSI will be completed in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
