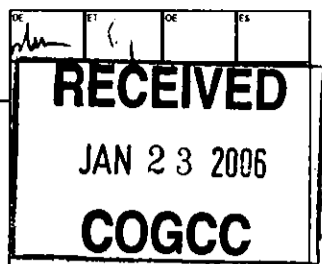

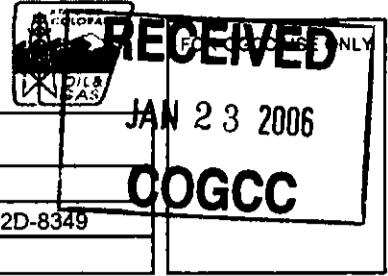

5. DESCRIBE PROPOSED OR COMPLETED OPERATIONS

During the drilling operation, all drill cuttings and drilling mud were placed in the reserve pit where they remained and dried by natural evaporation. Once the reserve pit was adequately dried, it was backfilled. The cuttings in the reserve pit were mixed with stockpile soil, and then covered with remaining stockpile. The remaining soil from the reserve pit stockpile was spread over the reserve pit. Topsoil was then spread over the location and contoured to natural slope, re-seeded and covered with certified straw.
