THE ASSOCIATED PIT APACHE CANYON 2-16V (FAC ID 268850) WAS CLOSED IN 2012 UNDER REMEDIATION PROJECT #6807. SOIL SAMPLES WERE GATHERED AND LAB ANALYSIS PRESENTED AT THAT TIME. THE INITIAL FORM 27 ASSOCIATED WITH THAT PROJECT IS DOC#200339720. THE ASSOCIATED PIT IS STILL PRESENT UNDER RELATED DOCUMENTS TO THIS LOCATION, THERE FOR THE REQUEST FOR PIT CLOSURE IS INCLUDED IN THIS FORM 27 FOR ECMC RECORDS ACCURACY PURPOSES. ALL SUPPORTING DOCUMENTS HAVE BEEN ATTACHED TO THIS FORM 27.

AS PART OF THE "CUT AND CAP OPERATIONS", THE APACHE CANYON 2-16V WELLHEAD WILL BE EXCAVATED. ONE SOIL SAMPLE WILL BE COLLECTED FROM AN AREA ADJACENT TO THE WELL. THE SAMPLE WILL BE SUBMITTED FOR LABORATORY ANALYSIS OF THE FULL LIST C SOIL CONSTITUENTS IN ECMC TABLE 915-1. BACKGROUND SOIL SAMPLES MAY BE COLLECTED FROM COMPARABLE, NEARBY, NON-IMPACTED SOIL TO ESTABLISH NATIVE SOIL CONDITIONS FOR PH, EC, SAR, METALS, AND HYDROCARBONS PER RULE 915.E.(2).D. PHOTOS, FIELD NOTE LOGS FROM THE SAMPLE EXCAVATION/COLLECTION, AS WELL AS LABORATORY ANALYSIS WILL BE INCLUDED WITH A FORM 27A.
