This Form 27 is being submitted to include a 2Q 2026 timeline update for the WELLS RANCH USX AA13-01 wellhead (REM #40473). A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of arsenic and lead are attributed to native soil conditions at the site. The results of the SSI will be submitted on a subsequent Form 27.

Three background soil samples were collected on August 18, 2025 and three background soil samples were collected on October 24, 2025 from areas not impacted by oil and gas development and at depths and lithologies (poorly graded sands – SP) comparable to those of the confirmation soil samples collected at the location. The samples were analyzed by a certified laboratory for Table 915-1 metals and SSR parameters using ECMC approved Methods. Additional background samples will be collected to determine site specific background concentrations of arsenic and lead.

This project is waiting for required background samples to be collected and analyzed. We anticipate that background samples at the site will occur on September 3, 2026. Access has been requested and is awaiting review.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
