Background samples will be collected from homogenous soil horizons and/or corresponding excavation sample depths.

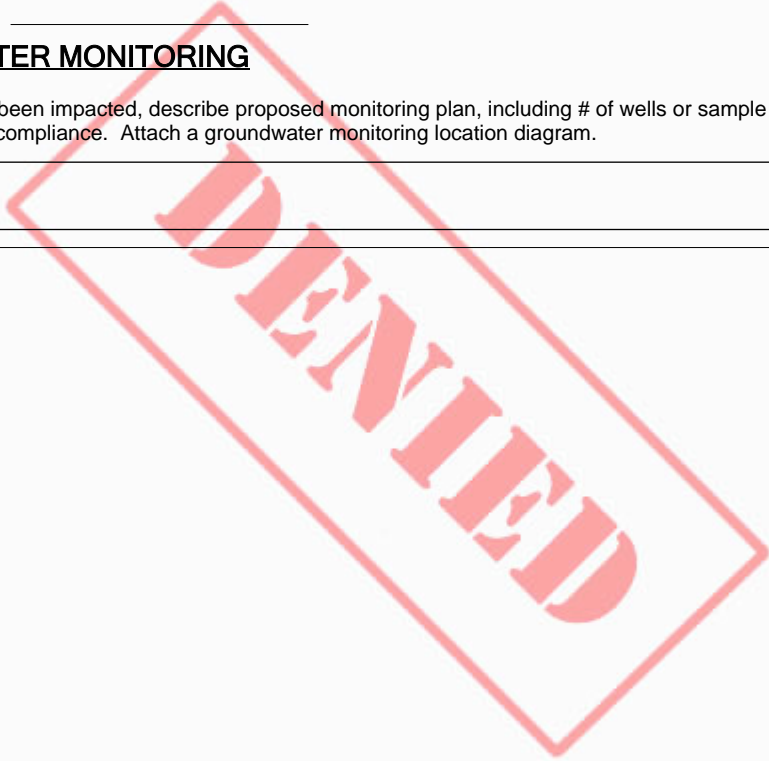
