INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HOFFMAN C02-65HN wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules on September 26, 2024. The confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Re-sampling was conducted. Approximately 330' of flowline was removed on October 17, 2024, and the ECMC was notified of flowline decommissioning activities on Form 44 Document #403241476.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

The confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Re-sampling was conducted. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples were analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All sample analysis was performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Wellhead and Flowline Closure Checklists were utilized and filled out during the abandonment process. Photologs were previously attached.

Were background samples collected as part of this site investigation?

Six site specific background soil samples collected from approximately 4 ft., and 6 ft-bgs from three soil borings (BKG01 through BKG03) were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods.

The confirmation soil samples and field screenings collected from the wellhead excavation were all classified as silty sands (SM). The six background soil samples were collected from the same depths as the confirmation soil samples with similar soil classification as the wellhead sample, clayey sands (SC), silty sands (SM), gravely clays (CL), and well graded sands (SW).

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 GWSSLs or 1.25x the highest background concentrations for barium (263 mg/kg), except for arsenic, lead, and selenium in WH01@6.

This form is being submitted as a 1Q26 timeline update for the HOFFMAN C02-65HN wellhead and flowline.

Facility closure activities and confirmation soil sampling were conducted at the wellhead and flowline on September 26, and October 17, 2024, respectively, and were summarized in Supplemental Form 27 #403996501.

Background sampling was conducted adjacent to the wellhead on April 8, 2025. The wellhead confirmation soil samples collected on September 26, 2024, were determined to have insufficient material when delivered to the laboratory and were not analyzed. Resampling was conducted on September 17, 2025. The results of these supplemental site investigation activities were summarized in Supplemental Form 27 #404424765.

Noble is in the process of pursuing, if an applicable well is adjacent to the site, produced water sampling to evaluate residual inorganic concentrations at the site. A supplemental site investigation proposal will be submitted on a subsequent Supplemental Form 27, as needed.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
