Pursuant to Rule 305 (B) of the Colorado Oil and Gas Commission, please be advised that Samedan Oil Corporation intends to commence the drilling of the above captioned well located in Yuma County, Colorado, at the location shown on the attached plat.

An Agent for Samedan Oil Corporation, is hand delivering this letter to you in order to discuss the proposed access for the well road and location. Mr. Dave Ledet is Samedan Oil Corporation's representative in Yuma, Colorado. Mr. Ledet's telephone number in Yuma is 970/848-0331 (cell 970/630 1076) should you need to contact him for any reason. A prepaid post card is enclosed to return if you wish to contact Samedan by mail.

A copy of the State of Colorado Oil and Gas Notification, Consultation and Reclamation Rules are enclosed for your review and files. Please note that according to these rules it is the responsibility of the surface owner to notify any tenants regarding these operations.

It is our desire to drill the captioned well as soon as the State permit is approved and a drilling contractor is located. Accordingly, we request you waive the thirty (30) or forty-five (45) day notice period provided for in Rule 305 (B) which will allow Samedan to move on and drill the captioned well as soon as a drilling permit is approved and the drilling contractor can be secured. 
