Interim areas are well established with rubber rabbitbrush, big sagebrush, intermediate wheatgrass and scarlet globemallow. Undesirable plant species at the location include cheatgrass, bulbous bluegrass, redstem fillaree and prickly Russian thistle. Cheatgrass is dominant in the southeastern portion of the interim area. Cheatgrass is present in the understory of the nearby reference area.
