Comment Interim areas are well established with big sagebrush, intermediate wheatgrass, western wheatgrass and rubber rabbitbrush. A closed pit to the east is well vegetated with perennial shrubs. Cheatgrass and redstem fillaree are dominant in the understory in the eastern and northwestern interim area. Kochia and prickly Russian thistle are present along the edges of the working pad surface. Weed maintenance is required within the interim areas of the location; see Good Housekeeping section for Corrective Action details. Overall, interim areas are progressing towards 1003 reclamation requirements.
