INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the Edens 11, 12, 18-52 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected from the produced water vessels (PWV01-B@5', PWV01-N@3', & PWV01-W@3'), beneath the ground oil tanks (AST01@0-6" & AST02@0-6") and beneath separator dump line/flowline riser (SEP01-FL@4' and SEP02-DL@4'). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of the tank battery decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was attached to a previous Form 27 (Doc #404228450).

Were background samples collected as part of this site investigation?

On 01/28/2026, twenty background soil samples were collected from five discrete location (BKG01-BKG05) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0 to 6 feet below ground surface (ft bgs). The maximum background concentration for pH and SAR were observed to be 7.83 and 6.02, respectively. The maximum background concentration with a 1.25x multiplier applied for arsenic, barium, and chromium were calculated to be 7.5 mg/kg, 254 mg/kg, and 0.76 mg/kg. All arsenic, barium, and chromium concentrations collected were below 1.25x the maximum background level.

Based on the analytical results collected, a supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the organic compound exceedances observed at sampling locations SB13@3-4', SB15@3-4', PWV01-N@3'. A proposed SSI map was attached to a previous Form 27 submittal (Doc #404541315). During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if pH and SAR is attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Decommissioning analytical results indicated that organic compounds were in exceedance with the applicable ECMC regulatory standards. A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the organic compound exceedances observed at sample locations AST02@0-6", PWV01-N@3', SEP01-FL@4', and SEP01-DL@4' in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.

A supplemental site investigation was completed on 01/28/2026 to vertically and horizontally delineate the organic exceedances observed during decommissioning activities. SB09 and SB10 were advanced at the same location as SEP01-FL@4' and SEP01-DL@4' to vertically delineate impacts on those locations. SB11-SB16 were advanced surrounding SB09 and SB10 to vertically and laterally delineate impacts identified at sample locations SEP01-FL@4' and SEP01-DL@4'. SB02 was advanced north of PWV01-N@3' to vertically delineate impacts on that location. SB01 and SB03-SB08 were not sampled due to frost levels and difficult soil base. Groundwater was not encountered during this assessment.

Based on analytical results received an additional supplemental site investigation will be completed to confirm and further vertically and horizontally delineate the organic compound exceedances observed at sample locations SB13@3-4', SB15@3-4', and PWV01-N@3' during decommissioning and the January 2026 SSI, in accordance with the proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
