Comment:

The well pad portion of the project area meets final reclamation vegetation standards and appears consistent with adjacent reference areas.

It was noted that sparse germination of new grass species was observed along recently seeded portions of the access road. Access road has not yet met final reclamation vegetation standards and future seeding efforts may be needed. Location will be inspected at a future date to assess establishment of seeded species along bare portions of the access road.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including storm water and weed management.
