Comment Interim areas are primarily composed of smooth brome. Bulbous bluegrass, a List C noxious weed species, is present in secondary amounts throughout. Tertiary amounts of big sagebrush and fourwing saltbush are present. Weed control is not required at this time; however, ongoing weed monitoring and maintenance is necessary until the location receives a passing final reclamation inspection. Overall, interim areas are progressing towards 1003 reclamation requirements.
