Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

At approximately 3:00pm on 5/14/2026 a contract work over rig was circulating the Pergamos 3-11-7-60 pad after the RBP was set. While circulating fluid to a work tank an unexpected gas bubble of this size and pressure reached the fluid riser on the work tank causing a bracket to break free. The riser swiveled up causing the circulating fluid to be misted into the air. A nearby workover hand immediately shut the circulation valve stopping the release of fluid, followed by isolating the well head valve as a secondary measure. The windy conditions carried the vaporized hydrocarbons off location into the adjacent pasture. Approximately 1 bbl of hydrocarbons were released. Contaminated road base and vegetation was cleaned up and disposed of.
