INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LUCCI B 01-23 flowline removal. Approximately 708' of flowline was removed on 10/3/2023. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure was utilized and filled out during the abandonment process. A detailed summary of flowline decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to Form 27 document number 403707326.

Fourteen background soil samples were collected on 10/3/2023 and 11/19/2024 from an area not impacted by oil and gas development and at depths and lithologies comparable to those of the confirmation soil samples collected at the location. The samples were analyzed by a certified laboratory for Table 915-1 metals and SSR parameters using ECMC approved Methods. Based on the background analytical results summarized below, the following Table 915-1 metals and SSR parameters were within the maximum observed background values (metals listed in mg/kg):

The implementation schedule has been changed due to the decommissioning of the LUCCI B 01-23 wellhead and flowline and necessity for supplemental site investigation activities adjacent to the wellhead and flowline. The ECMC will be notified of any update to the implementation schedule on a supplemental Form 27.

OPERATOR COMMENT

This Form 27 is being submitted to include a 2Q 2026 update for the LUCCI B 01-23 wellhead and flowline (REM #30908). A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if elevated levels of pH, SAR and arsenic are attributed to native soil conditions at the site. The results of the SSI will be submitted on a subsequent Form 27.

After further review the background soil samples collected (BKG01@4', BKG02@4', and BKG 1) were determined to be within the historic oil and gas impacted area and will not be used to determine site specific background concentrations of Table 915-1 metals in soil and SSR parameters per ECMC Table 915-1.

Fourteen background soil samples were collected on 10/3/2023 and 11/19/2024 from an area not impacted by oil and gas development and at depths and lithologies comparable to those of the confirmation soil samples collected at the location. The samples were analyzed by a certified laboratory for Table 915-1 metals and SSR parameters using ECMC approved Methods. Based on the background analytical results summarized below, the following Table 915-1 metals and SSR parameters were within the maximum observed background values (metals listed in mg/kg):

Barium Max*1.25 = 148.75

Additional background samples will be collected to determine site specific background concentrations of pH, SAR and arsenic.
