Twelve grab soil samples were collected from the decommissioned tank battery and two composite soil sample was collected from the stockpiled overburden. All soil samples were submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron.

Source removal is ongoing. Grab confirmation soil samples will be collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron to determine the lateral and vertical extent of impacts. Additional background samples will be collected from homogenous soil horizons and/or corresponding excavation sample depths.

Subsequent to source removal, a groundwater site assessment will be scheduled to determine the extent of impacted groundwater.
