INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the UPRC Lot T4N-R67W-S23 L01 / UPRC 64N67W 23SESW Facility and Tank Battery location. The facility and tank battery were decommissioned per ECMC rules on 08/08/2024. Grab soil samples were collected at the produced water vessels excavation, the oil-water separator, and the above ground oil tank. Additionally, soil samples were field screened at the N-E-S-W sidewalls of the produced water tank excavation.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Six grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, at the risers for the flowlines and dumphine of the separator. In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of ECMC Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

During the initial decommissioning on 08/08/2024, four background samples were collected from one soil boring (BKG01). Due to sample collection within areas of historical oil and gas infrastructure, sample BKG01 will not be used for comparison of native conditions. Five soil samples exceeded the ECMC Table 915-1 Soil Suitability Limits for pH at sample locations PWV01-B@4' (8.32 Standard Units (SU)), PWV01-N@2' (8.77 SU), SEP01-DL@2' (8.59 SU), SEP01-FL@2' (8.39 SU), SEP02-FL@3' (8.39 SU).
