On 02/12/2026, GOLLNER O 27-03 wellhead decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents were present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 2/26/2026 indicate that soil sample FL01-W-R, discovered at the wellhead, exceeded ECMC Table 915 standards for 1-methylnaphthalene at 0.0090 mg/kg. Groundwater was not encountered during decommissioning activities. This location is located within the Municipality of Milliken. A supplemental Form 27 has been submitted for remediation project number 43711 detailing the remedial site plan, document number: 404559937.
