Final reclamation vegetation standards have been met at the reclaimed well pad area, vegetation transects have been included in the previous inspection doc #714001273. It was noted that the associated access road remains unreclaimed per 1004 rules. Previous inspection doc #714001273 also made note that operators previous variance doc #402542080 has not been approved and requires resubmitting per Rule 502.a and 2021 rule change. It was noted that no new variance has been submitted.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including storm water and weed management.
